PRIVACY POLICY

Leading Edge Associates, LLC ("Leading Edge") respects the privacy of every individual and is committed to protecting your privacy. This Privacy Policy (the "Privacy Policy") provides information on the manner in which your personal information obtained through your use of www.leateam.com or related sites (together, the "Website") is processed and used on this Website. Leading Edge uses your personal information only in ways that are compatible with this Privacy Policy. In addition to reviewing this Privacy Policy, please read our Terms and Conditions of Use.
